Membership Process

1. Member form is to be completed by the applicant.
2. The applicant must attend a club meeting to present their completed application, together with their money and provide proof of ownership of their Mustang (meetings held every 4th Wednesday of the month at the Sporting Car Club, 51 King William Road, Unley.
3. All Applications are required to be nominated and seconded by two (2) current financial members of the Mustangs on the Move Club.
4. Prior to acceptance as an MOTM member, all Applications are presented to existing members for membership comment.
5. Proposed new member are then contacted and informed if their membership has been accepted or rejected.
6. New Members must attend a second club meeting to receive their official membership pack.
7. Conditional Registration will only be available once the applicant has been accepted as a member (approximately 2-3 weeks after presenting application to club meeting). Conditional registration officers will be notified of all new members.

Where a new member is located more than 75 kilometres from Adelaide GPO, they must present themselves with their completed application form to a committee member with proof of ownership of a Mustang. The committee member will present their application at the next club meeting on their behalf.
